RP assists with the origination, servicing, refinancing, and liquidation of loans issued pursuant to SBA's loan programs, as well as program management, risk management, loan systems management, financial analysis, legal support and small business program certification support and management. In addition, RP provides multi-user system data processing, PC/networking environment support, and business systems and professional management within OCA.

### Office of Capital Access **Paycheck Protection Program Loan Forgiveness Program**

RP conducts borrower outreach to provide a direct path to forgiveness on loans less than \$150,000 that do not have hold codes. RP personnel contact borrowers via phone and email, providing forgiveness processing through the Direct Forgiveness Platform, processing forgiveness applications, and providing SBA recommendations.

**Since September 2023, RP has enabled \$5.5M in borrower forgiveness via 24,000 outreach attempts (phone, email).**
